

SPRINGFIELD GETAWAY DRAWING RULES

I. NAME OF SPRINGFIELD GETAWAY DRAWING SPONSOR

Abraham Lincoln Presidential Library and Museum (Hereinafter referred to as "Sponsor").

II. ELIGIBILITY

Entrants must be legal residents of the United States age 18 years and older as of entry date. Any individuals (including but not limited to employees, consultants, independent contractors, and interns) who have, within the past six months, performed services or volunteered for Sponsor or the Illinois Historic Preservation Agency, or any organizations responsible for sponsoring, fulfilling, administering, advertising or promoting the drawing or supplying the prize, and/or their respective parent, subsidiary, affiliated and successor companies, and immediate family and household members of such individuals, are not eligible to enter or play. "Immediate family members" shall mean parents, step-parents, children, step-children, siblings, step-siblings, or spouses. "Household members" shall mean people who share the same residence at least three months a year.

Entries remain the property of Sponsor and will not be returned or acknowledged. The drawing begins June 1, 2010 and all entries must be received by August 1, 2010.

Winners will be notified by phone or by email depending on information supplied. Limit one prize per winner for this getaway drawing. Odds of winning depend on number of valid entries received. Many will enter, only ten will win.

V. PRIZE(S)

10 winners will each receive:

- A gift certificate good for 4 admissions to the Abraham Lincoln Presidential Museum in Springfield, IL
- Two nights at either the Hilton Springfield or the Statehouse Inn in Springfield – one standard room for four people.
